Innovative developments and applications in technology have propelled the hospitality industry forward. These developments are the result of hard work and creative thinking by individuals who had the vision to see what technology could mean to the future of the hospitality industry. In recognition of these visionaries and their impact on the hospitality industry, HFTP established the International Hospitality Technology Hall of Fame in 1989.

The International Hospitality Technology Hall of Fame is HFTP’s highest level of recognition in the area of technology. Hall of Fame members are selected by their peers as representing the best in innovation and application and as leaders in their profession.

Eligibility

To be eligible for induction into the Hall of Fame, an individual must have made significant and lasting contributions to hospitality technology in any or all of the following areas:

- **Development** — Developed a product or service that has significantly improved the industry.
- **Application** — Through the successful application of technology, advanced the industry and improved guest service.
- **Promotion** — Through his or her promotional efforts, significantly expanded the role technology has played in the hospitality industry.

Nomination Process

Step 1.

Fill out the attached form and submit the information to HFTP by the stated deadline. The deadline is annually in mid-April with the exact date for that year listed on HFTP.org. Nominations are good for two years.

Step 2.

Submit nomination support material which is due two weeks after that year’s deadline. Material must be submitted in a digital format. Nomination material detailed on the following pages of this application.

It is the responsibility of the nominator to notify the nominee of the nomination. HFTP will not notify the nominee or coordinate the collection of support material for the nominee.

Selection

The Hall of Fame recipient is selected by a distinguished panel of technology experts and HFTP leaders. Up to two inductees will be selected in a year.

Presentation

The honoree(s) will be honored at that year’s HITEC® North America.

Nomination Support Material

Nominees are asked to submit a resumé or biographical sketch outlining their accomplishments in the hospitality technology field, along with three letters of recommendation from individuals who have a firsthand knowledge of the nominee's qualifications.

The materials submitted must include:

- Examples of technology products or services the nominee has developed, enhanced or applied to advance the industry;
- Leadership roles the nominee has held in businesses, professional associations or other organizations that have promoted the use of technology in the industry;
- Specific examples of what the nominee's work has meant to the industry in terms of productivity, efficiency and lasting change;
- The period(s) of time in which the nominee made these contributions; and
- In the letters of reference, thoughts about the nominee's professional integrity, stature and leadership abilities above and beyond the specific contributions listed above.
